This **bright, juicy red** pairs well with **richer poultry dishes such as duck**, as well as **mushrooms and cured meats**. It is produced from vines planted between 1997-2002 within the Dão wine region at 500m (1,640') elevation, growing in **granite-based soil with lines of clay and sand**. Average temperature during the April-October growing season is 18.5° C (65.3° F); annual rainfall is 660mm (26"). It is aged **18 months in second-year French barrels**.
